CONDITIONS OF SUPPLY

1. If any amount is overdue, the water Supply shall be disconnected under the provisions of Water Act 2002 and the By-laws governing the consumers Association.

2. The water undertaker shall have the right forthwith and without notice terminate the agreement for any breach by the consumer to the conditions of supply but without prejudice to any antecedent right against the consumer including the right to take proceedings.

3. No consumer shall convey or permit to be conveyed by any means whatever; for use outside his plot or sale any water supplied to him by the undertaker.

4. According to the regulations the consumer shall deposit Kshs..... which shall be retained by the water undertaker for the period during which the consumer is supplied with water.

5. The consumers' responsibility begins immediately after the meter towards his/her house irrespective of the length of pipeline financed by him/her.

6. It is the responsibility of the consumer to give access to the meter and premises to the event of no such access being granted.

7. NO consumer shall use or permit to be used any water supplied in pursuance of an application made by him in this form except for such use as specified by him in his application.

I hereby request you to supply water to the property shown above and I agree to abide by the terms and conditions, specified in the Association By-laws and hold myself responsible for payment of all water and meter rent until such a time as the agreement is terminated in accordance with the Association By-laws.
